

# **Indexed List of Files Harradine Report 2024 Australian Fisheries Management Authority AFMA**

AFMA publish an indexed list of files created by the agency every 6 months in accordance with [the Senate Order 12-Indexed lists of departmental and agency files](#).

The listing does not include:

- files transferred to the National Archives
- case related files – for example personal representations or files dealing with personal affairs of departmental or agency clients or taxpayers.
- files related to the internal administration of the agency such as staff or personnel matters.
- Files containing commercially confidential information
- Files with a national security classification of Confidential, Secret, Top or their equivalent.
- Files which would disclose deliberations and decisions of Cabinet

In accordance with the order, some information in file titles has been deleted.

## **Background**

On 14 November 1994, the Senate agreed to a motion by Senator Harradine requiring all Australian Government departments and agencies to produce an indexed list of files every six months for tabling before parliament. The list makes the operations of government clearer to the Australian public.

The Senate Order was amended in December 1998 to require all government departments and agencies to list these files on their website.

- created between 1 January and 30 June of that year in the central office of that department or agency – not later than the tenth day of the spring sittings.
- created between 1 July and 31 December of the preceding year in the central office of that department or agency – not later than the tenth day of the autumn sittings
